City Council was called to order by Mayor, Jeff Westlake at 5:30 PM on Monday, June 17, 2024. Roll was called and present were members Matt Goldsworthy, Michele Brewster, Mike Aker, Ron May, Ashley Hilfiker, Dave Golden, and Kent McClung. Also, present was Clerk-Treasurer, Lori Phillips, Wes Schemenaur, Rob Weaver (WPGW) and Ray Cooney (CR).

### Pledge of Allegiance

### Approval of City Council minutes from June 3, 2024

Motion by May, seconded by Hilfiker to approve the City Council minutes from the June 3, 2024 meeting as presented. Roll call vote. All voted aye.

# <u>Second reading of Ordinance 2024-8; Amending Chapter 30; Section 30.34 – Contempt and Disorderly Conduct in Public meetings</u>

Motion by May, seconded by Brewster to pass ordinance 2024-8 on the second reading. Roll call vote. All voted aye. This ordinance protects public meetings from being disrupted due to inappropriate public behavior.

## Second reading of Ordinance 2024-9; Amending Chapter 51.16; Water Deposit

Motion by May, seconded by Golden to pass ordinance 2024-9 on the second reading. Roll call vote. All voted aye. This ordinance increases the water deposit from \$100 to \$150 for all new customers. This ordinance will not affect current customers that have a deposit on file.

### First reading - Ordinance 2024-10; Amending Chapter 74, Stop Intersections

Motion by Golden, seconded by McClung to pass ordinance 2024-10 on the first reading. After a lengthy discussion, roll call vote was taken. Aker, Golden, Hilfiker and McClung voted aye. Goldsworthy, Brewster and May all voted nay. Motion passed on the first reading. Second reading is scheduled for the July 1<sup>st</sup>. This ordinance places a 4-way stop at the intersection of Water and Middle Street.

# Request for additional funds (\$9,000) to update Police Department SOPs, Rules, Regulations and Policies

Mayor Westlake recommended that Charles Braun (Attorney at Law) update the police department documents. He noted that he did reach out to Bliss McKnight. They will review departments SOP's, but they do not update or write the documents. Again, Wes was asked if he could write the police department documents. Wes noted that he would meet with Chief Mock to receive the scope of the project and will put together an estimate to complete the project.

Motion by McClung, seconded by Golden to approve the funds and for the BOW to approve a contract for this service. Roll call vote. All except May voted aye.

## <u>Travis Richards, PP Tax Abatement for Joyce Dayton - Request to send to the Tax Abatement</u> Board

Motion by McClung, seconded by Goldsworthy to approve sending the tax abatement to the Tax Abatement Advisory Board. Roll call vote. All voted aye.

  policies in the complaints by Chief Mock and other police officers against Clerk
  Treasurer, Lori Phillips. Golden, McClung and Hilfiker complimented and thanked
  Phillips for doing a great job as Clerk Treasure for the City of Portland.
- 2. Asked who is responsible for following up on Development Agreements; such as, Rollin J Lanes. Travis noted that he was unsure. Lori contacted Travis in January to let him know that the agreement had expired and needed an amortization chart for repayment. Travis was advised to make contact with Rolling J Lanes to follow up on the agreement. No action has been taken. Wes noted that, if needed, he would assist to collect on this debt. Travis and Mayor Westlake will reach out to Rollin J Lanes on this matter.
