Council Comments

Matt-

Presented a letter regarding a noise complaint. City Ordinance 91.03 (J) Noise Ordinance Exemptions – Sounds produced in connection with a religious practice, function, or celebration.

Portland resident noted that he lives 2 blocks from the Community Center and a religious group meets there every Friday, Saturday and Sunday. He noted that their music is so loud that it rattles his windows. Other

area residents have also complained. The Community Center has been contacted and so far, the noise level has not decreased.

Also 91.03 (F) references a noise exemption for athletic events.

Matt suggested that the council research this ordinance and see if better language can be applied.

Ron-

- 1. Questioned the "No Turn on Red" signs on Meridian Street. Mayor Westlake noted that this is per INDOT standards due to the bump-outs.
- 2. Noted all of the drone sitings in Jay County and asked if residents could shoot them down. Wes advised against this. At this point there is nothing that can me done with this situation.
- 3. Asked why businesses could not have access to use city toters and the city trash service. Lori noted that this is per ordinance and the trash collection fees are set for residential only.
- 4. Asked if the Portland City Police are ready to assist the Federal Government with local immigration issues. Mayor Westlake noted that the officers are prepared.

Asked for an update on Blaine Pike. Lori noted that there is a no cost change order that will be presented to the Board of Works on Thursday. Once the has been approved and submitted to INDOT, the close-out process will begin.
