# Aaron Loy, Jay County Fair Board - Request for funds

A funding request was made in the amount of \$6,500. The funds will cover the cost of the design and construction of this year's sunflower/ corn maze. All voted aye.

Motion by May, seconded by Brewster to approve closing Main Street from Commerce to Ship from 9am to 9pm on June 14<sup>th</sup>. The Greazy Pickle will be hosting benefit events for Aaron Emerick / Alyssa Man. Roll call vote. All voted aye.

### **Council Comments**

Matt - Regarding the noise ordinance – what refines a "religious" group? Wes noted that would be a difficult one to define.

#### Ron -

- 1. Recognized Mike Weitzel and Dustine Hilfiker for getting State Certified in Live Fire Training. This was an intense 5-week course with 39 burns in burn chambers.
- 2. Requested an update on parking in front of City Hall. Mayor Westlake noted that INDOT is working with city officials to regain parking spots at this location and a few others downtown.
- 3. Requested an update on the barricades that remain downtown. Mayor Westlake noted that city officials are working with INDOT on an acceptable design to make the drop offs safer. The options that have been proposed are additional flower pots (provided by INDOT) and hand rails.
- 4. Questioned if the city would be maintaining the walking path on Blaine Pike. He noted a recent incident when a resident plowed that path and caused minor damage to a homeowner's yard along the path. Mayor Westlake noted that that city does not maintain this path or the Hudson Park walking path.
  - \*\*Note\*\* The city does not have the appropriate equipment for plowing a walking path. An enclosed, heated Kubota with a plow would be needed.
- 5. Requested an update from Mayor Westlake on how illegal immigration in Portland will be handled. Mayor Westlake noted that there is sensitive information that cannot be shared with the public at this time.

#### Kent -

- 1. SB-1 is back to the original verbiage.
- 2. Immigration discussion Follow the law, follow the Constitution of the United States and avoid racially profiling individuals.

# Ashley -

- Requested from Wes what can be done when Mayor Westlake picks and chooses which
  ordinances are being enforced. Wes noted the separation of power. The Council makes
  the ordinances and Mayor, Police and Code Enforcement enforce the ordinances.
- 2. Asked that the council discuss the ordinance regarding solicitors. She would like to review the process to be approved as a door-to-door solicitor. Also, the possibility of notifying the public of such solicitors.

# Dave -

- 1. State representatives are hosting an event this Saturday @ 9am Dunkirk Community Center to discuss SB-1.
- 2. Requested that Wes review at the noise ordinance. Wes noted that he will meet with the mayor and chief and report back to the council with some options.
