Minutes of Board of Public Works and Safety Meeting of March 6, 2025

Motion by Leonhard, seconded by McIntosh to approve the minutes of the March 6, 2025 Board of Public Works and Safety meeting as presented. Chair voted aye.

Life Works Counseling & Wellness agreement

Motion Leonhard, seconded by McIntosh to approve the amended agreement. Chair voted aye. The original agreement was signed in January of 2023. The amendment includes change of invoicing procedure and adding post-incident debriefing / counseling.

Choice One Engineering - Agreement for professional services; CCMG 2025-1

IMW - Proposal for Quarterly groundwater monitoring and drum removal; Plume 2

Additional costs as needed is \$1,200 for drum disposal — up to 2 times per year. Monitoring is for the following wells: MW3, 5, 9, 12, 13 and 14. Plume 2 is located at the north end of the former Sheller Globe; now TLS By Design. Chair voted aye.

Pay Request #9; James S. Jackson, WWPS, Contract 4A

Motion by Leonhard, seconded by McIntosh to approve Pay Ap #9. Chair voted aye. Pay #9 - \$727,183; 10% Retainage = \$72,718.30; Payment at this time = \$654,464.70. This pay request is for the period of February 1 through February 28, 2025.

Blaine Pike - Change Order #10; Lost time

Change Order #10 was presented for lost time when multiple water breaks occurred during the project. This change order was not approved at the March 6th BOW meeting. INDOT has approved the change order from their end. The City of Portland is 100% responsible for change order #10 in the amount of \$8,596.16.
