Approval of City Council Minutes from July 7, 2025

Motion by May, seconded by Hilfiker to approve the City Council minutes from July 7th, 2025 as presented. Roll call vote. All voted aye.

Jay County Bridge Dinner Committee

Darlesia Lee from the bridge committee shared information about an event they are planning for September 25th. The group wants to host a community picnic on the green bridge. Ron May suggested that committee set a budget and come back to council with a request.

Randy Stephen, Ohio Valley - Concerns over Ordinance 2025-6

Last month the council approved this ordinance which requires an application and a fee for all road cuts in the city's right of way. Randy expressed the undue burden this would put on their customers. The council agreed to table this topic while the mayor schedules a meeting with Randy to resolve this matter. Wes will amend the ordinance with the mayor's proposed changes and bring it back to council.

Motion by McClung, seconded by Goldsworthy to approve the personal property tax abatement for Pioneer Leasing. Roll call vote. All voted aye.

Investment: \$3,500,000 Abatement: 3 years Savings: \$91,087

Ordinance 2025-8; 2026 Payroll Ordinance – 2nd reading

Motion by Golden, seconded by McClung to approve the 2026 payroll ordinance on the 2nd reading. Roll call vote. May voted nay. All others voted aye.

Council approved a 2% increase for all full-time and elected officials. Mayor Westlake again advocated for a 3% wage increase.
