§ 70.01 DEFINITIONS.

Terms used in this Traffic Code shall have the meanings prescribed for such terms by the motor vehicle laws of Indiana, unless otherwise specifically defined as a part of this chapter. For the purpose of this chapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

"CAMPER." Any recreational vehicle whose combined length exceeds 20 feet.

"<u>ORDINANCES.</u>" The ordinances of the City of Portland and all amendments thereto.

"<u>POLICE OFFICER.</u>" Every officer of the city and any other duly constituted law officer who may be aiding the police force of said city at any time, including state and county officers.

"<u>TIME STANDARD.</u>" All reference to time contained in this Traffic Code shall be the time standard that is used by the city at any given time and which may change periodically.

"<u>TRAFFIC CODE.</u>" The Portland Traffic Code.

"TRUCK." A vehicle that has more than two rear wheels, or more than one rear axle, or has an empty vehicle weight of more than 5000 pounds. (Ord. 1978-13, passed 2-5-79)

§ 70.02 REFERENCE TO STREETS.

Any reference in this Traffic Code to a specific street, avenue, or drive shall be deemed to be a reference to the exact and correct name of such street so long as the first part of the name before the word street, avenue, or drive, as the case may be, is correctly stated. (Ord. 1978-13, passed 2-5-79)

§ 70.03 AUTHORITY OF POLICE.

(A) It is the duty of the Police Department to enforce the provisions of this Traffic Code. Officers of the Police Department are hereby authorized to direct all traffic either in person or by means of visible or audible signal in conformance with the provisions of this chapter, provided that in the event of a fire or other emergency or to expedite traffic or to safeguard pedestrians, officers of the Police or Fire Departments may direct traffic as conditions may require, notwithstanding the provisions of this chapter.

(B) The Police Department is hereby empowered to make and enforce regulations necessary to make effective the provisions of this Traffic Code and to make and enforce temporary regulations to cover emergencies.

(C) It shall be unlawful for any person to refuse or fail to comply with any lawful order, signal, or direction of a police officer. (Ord. 1978-13, passed 2-5-79) Penalty, see § 70.99

§ 70.04 FEE FOR CERTIFICATION OF REGISTRATION INSPECTION.

(A) Pursuant to IC state law, a fee is hereby established for the services of the police officers of the city when called upon by citizens to inspect a vehicle and verify the registration numbers of said vehicle.

(B) The fee for said inspection should be the sum of \$5.

(C) There is hereby created a "Special Vehicle Inspection Fund" to which all charges for said services shall be deposited and the law enforcement officer making said inspection shall issue a receipt on general form number 352 for each said fee collected and deposited in the "Special Vehicle Inspection Fund". Each officer shall forthwith after collection of said fee, deliver the same to the Clerk-Treasurer for proper deposit and recording. The said "Special Vehicle Inspection Fund" may only be expended after appropriation for law enforcement purposes. All expenditures shall be processed, appropriated, claimed and allowed in the same manner as other claims of the municipality. (Ord. 1988-15, passed 12-65-88; Am. Ord. 1993-10, passed 8-23-93)

TRAFFIC-CONTROL DEVICES

§ 70.15 AUTHORITY TO INSTALL TRAFFIC-CONTROL DEVICES.

The city shall place and maintain official traffic-control devices when and as required under the Traffic Code of this city to make effective the provisions of said

ordinances, and may place and maintain such additional official traffic-control devices as it may deem necessary to regulate, warn, or guide traffic under the traffic ordinances of this city or Indiana Motor Vehicle Laws. (Ord. 1978-13, passed 2-5-79)

§ 70.16 MANUAL AND SPECIFICATIONS.

All traffic-control signs, signals, and devices shall conform to the Indiana Manual on Uniform Traffic Control Devices for Streets and Highways as approved by the Indiana State Highway Commission. All signs and signals required hereunder for the particular purpose shall so far as practicable be uniform as to type and location throughout the city. All traffic-control devices so erected and not inconsistent with the provisions of state law or this title shall be official traffic-control devices. (Ord. 1978-13, passed 2-5-79)

§ 70.17 OBEDIENCE TO TRAFFIC-CONTROL DEVICES.

The driver of any vehicle shall obey the instructions of any official traffic-control device applicable thereto placed in accordance with the provisions of this title, unless otherwise directed by a police officer, subject to the exceptions granted the driver of an authorized emergency vehicle. (Ord. 1978-13, passed 2-5-79) Penalty, see § 70.99

§ 70.18 TRAFFIC LANES.

The city is hereby authorized to mark traffic lanes upon the roadway of any street or highway where a regular alignment of traffic is necessary. (Ord. 1978-13, passed 2-5-79)

§ 70.99 GENERAL PENALTY.

Any person, firm, or corporation violating any of the provisions of this Traffic Code for which no specific penalty is otherwise provided, upon conviction thereof, shall be fined for each violation any sum not exceeding \$100. (Ord. 1978-13, passed 2-5-79)

§ 71.01 SPEED LIMITS.

The Indiana motor vehicle laws regulating the speed of vehicles shall be applicable upon the streets within this city, except as this Traffic Code, as authorized by Indiana motor vehicle law, hereby declares and determines upon the basis of an engineering and traffic investigation that certain speed regulations shall be applicable upon specified streets or in certain areas, in which event it shall be unlawful for any person to drive a vehicle at a speed in excess of any speed so declared in this Traffic Code when signs are in place giving notice thereof. (Ord. 1978-13, passed 2-5-79) Penalty, see § 70.99

§ 71.02 EMERGING FROM ALLEY.

The driver of a vehicle emerging from an alley, driveway, or building shall stop such vehicle immediately prior to driving onto a sidewalk or into a sidewalk area extending across any alley or private driveway. (Ord. 1978-13, passed 2-5-79) Penalty, see § 70.99

§ 71.03 DUTY TO STOP WHEN TRAFFIC OBSTRUCTED.

No driver shall enter an intersection or a marked crosswalk unless there is sufficient space on the other side of the intersection or crosswalk to accommodate the vehicle he is operating without obstructing the passage of other vehicles or pedestrians, notwithstanding any traffic-control signal indication to proceed. (Ord. 1978-13, passed 2-5-79) Penalty, see § 70.99

§ 71.04 DRIVER TO EXERCISE DUE CARE.

Notwithstanding other provisions of this Traffic Code every driver of a vehicle shall exercise due care to avoid colliding with any pedestrian upon any roadway and shall give warning by sounding the horn when necessary and shall exercise proper precaution upon observing any child or any obviously confused or incapacitated person upon a roadway. (Ord. 1978-13, passed 2-5-79) Penalty, see § 70.99

§ 71.05 FUNERAL OR OTHER PROCESSIONS.

Each person who is driving in a funeral or other procession and each person who is not driving in a funeral or other procession shall comply with the requirements of IC 9-21-13. (Ord. 1978-13, passed 2-5-79; Am. Ord. 2020-15, passed 11-16-20) Penalty, see § 70.99

§ 71.06 EMERGENCY VEHICLES.

(A) The driver of an authorized emergency vehicle, when responding to an emergency call or when in the pursuit of an actual suspected violator of the law or when responding to but not upon returning from a fire alarm, may disregard regulations governing direction of movement or turning in specified directions as required by this section.

(B) The exemption herein granted to the driver of an authorized emergency vehicle shall apply only when the driver of the vehicle while in motion sounds an audible signal by bell, siren, or exhaust whistle as may be reasonably necessary, and when the vehicle is equipped with at least one lighted lamp displaying a red light visible under normal atmospheric conditions from a distance of 500 feet to the front of such vehicle, except that an authorized emergency vehicle operated as a police vehicle need not be equipped with or display a red light visible from in the front of the vehicle.

(C) The foregoing provisions shall not relieve the driver of an authorized emergency vehicle from the duty to drive with due regard for the safety of all persons, nor shall such provisions protect the driver from the consequences of his reckless disregard for the safety of others. (Ord. 1978-13, passed 2-5-79) Penalty, see § 70.99

§ 71.07 TRUCK REGULATIONS.

(A) No person shall drive or operate, or cause to be driven or operated any truck upon the streets, bridges, and culverts within the city, except on designated and marked city truck routes as described in Chapter 74, Sch. XI.

(B) The restrictions as herein set forth on trucks shall not be applicable to trucks delivering or picking up goods and property at places not located on designated and marked city truck routes, provided such trucks are only operated by the shortest way possible between the designated and marked city truck route and the place of delivery or pickup or as otherwise directed by a police officer. The restriction is not applicable to refuse or garbage trucks regularly operating within said city while in the process of picking up refuse and garbage from the residences and business places within the city. (Ord. 1978-13, passed 2-5-79) Penalty, see § 70.99

§ 71.08 BICYCLES AND MOTORIZED BICYCLES.

Parents or guardians of minors who knowingly or intentionally allow the minor to operate bicycles or motorized bicycles on the roadway in violation of IC 9-21-11, as amended or recodified may be fined in an amount not to exceed \$2,500 per occurrence. The parent or guardian of a minor is presumed to have knowledge of the operation in violation of Indiana Code. This presumption is rebuttable.

§ 71.09 PROHIBITING THE USE OF ENGINE COMPRESSION BRAKES.

(A) No truck shall use engine compression brakes or an engine retarder system to stop or slow down the truck if the system causes the

truck's motor to race in such a manner as to cause the exhaust system to emit a loud, cracking, backfiring, or chattering noise unusual to its normal operation. The practice being commonly known as "jake braking". Appropriate signage shall be placed at or near the city limits as required by IC 9-20-1-3.

(B) Violation of this section may be punishable by a fine not to exceed \$500.

(C) This prohibition must be designated by appropriate signs placed at or near the city limits as required by I.C. 9-20-1-3(C)(2). (Ord. 2011-6, passed 9-19-11; Am. Ord. 2020-15, passed 11-16-20)

 \underline{S} 71.10 MINIMUM PASSING DISTANCE WHEN OVERTAKING A BICYCLIST.

(A) <u>Definitions.</u> Terms used in this section shall have the following meanings:

"<u>BICYCLE.</u>" Any foot-propelled vehicle, irrespective of the number of wheels in contact with the ground.

 $\ensuremath{\underline{``BICYCLIST.''}}$ A person using a bicycle.

"DRIVER." A person driving, operating, or in actual physical control of a vehicle.

"OPERATOR." Every individual who shall operate a vehicle as the owner thereof or as the agent, employee or permittee of the owner or who is in actual physical control of a vehicle.

"<u>ROADWAYS.</u>" That portion of a public street, alley or highway designed, improved or ordinarily used for vehicular traffic.

(B) <u>Overtaking or passing a bicyclist</u>. The driver or operator of any motor vehicle driving on the roadways of Portland may overtake or pass a bicyclist when there is a safe distance of not less than three feet between the motor vehicle and the bicycle.

(C) <u>Returning to original lane.</u> The driver or operator of any motor vehicle on the roadway of Portland shall not return to the original lane until the vehicle is safely clear of the bicycle(s).

(D) <u>Compliance with applicable regulations in</u> <u>this section.</u> All drivers, operators, and bicyclists are required to comply with the applicable regulations set forth in this section.

(E) <u>Penalty.</u> Any person violating any of the provisions of this section shall upon conviction thereof, be subject to fine for each violation of any sum not exceeding \$100. (Ord. 2015-8, passed 6-1-15)

§ 71.11 DESIGNATED CROSSWALK.

(A) A crosswalk for pedestrian traffic shall be established on East Walnut Street between Meridian Street and Wayne Street.

(B) The crosswalk shall be marked on the surface of East Walnut Street and necessary signage installed.

(C) The Superintendent of the Portland Street Department shall determine and apply appropriate striping and post necessary signage.

(D) All motorized vehicles shall stop and yield the right-of-way to pedestrian traffic using the crosswalk.

(E) The penalty for violation of this section shall be the same penalty provided in § 70.99 of the Portland Code of Ordinances. (Ord. 2021-13, passed 9-20-21)

§ 72.01 PARKING POSITION.

Except where angle parking is permitted, a vehicle stopped or parked upon a roadway shall be stopped or parked with the curb-side wheels of the vehicle parallel with and within 12 inches of the curb or edge of the roadway. On a two-way traffic street, a vehicle shall only be parked on the right side of the roadway. (Ord. 1978-13, passed 2-5-79) Penalty, see § 72.99

§ 72.02 UNAUTHORIZED SIGNS.

No person shall place any sign along or on any street or alley or designate any place thereon with the intent to regulate or prevent the parking of vehicles on any street or alley. (Ord. 1978-13, passed 2-5-79) Penalty, see § 72.99

 $\$ 72.03 parking prohibited in certain locations.

No person shall stop, stand, or park a vehicle at any time for any purpose in any of the following places, except when necessary to avoid conflict with other traffic or in compliance with the direction of a police officer or trafficcontrol sign or signal:

(A) Within an intersection.

(B) On a crosswalk.

(C) Between a safety zone and the adjacent curb or within 20 feet of points on the curb immediately opposite the ends of a safety zone, unless the Police Department shall indicate a different length by proper signs.

(D) Within 25 feet from the intersection of curb lines.

(E) Within 30 feet upon the approach of any flashing beacon, stop sign, or trafficcontrol signal located at the side of the roadway.

(F) Within 20 feet of the driveway entrance to any fire station.

(G) Within 15 feet of any fire hydrant.

(H) In front of any public or private driveway.

(I) On a sidewalk.

(J) Alongside of or opposite any street excavation or obstruction when such stopping, standing, or parking would obstruct traffic.

(K) On the roadway side of any parked vehicle, commonly known as double parking.

(L) Upon any bridge or under any elevated structure.(Ord. 1978-13, passed 2-5-79) Penalty, see § 72.99

§ 72.04 STOPPING IN FRONT OF BUILDINGS.

No person shall stop, stand, or park a vehicle in any of the following places at any time except temporarily during the actual loading or unloading of passengers or when necessary in obedience to traffic regulations or traffic signs or signals, or the directions of a police officer: within a space of 25 feet immediately in front of the entrance of any church, school, hotel, theatre, motion-picture house, hospital, steam railway station, bus or interurban station, public meeting place, or public meeting hall. (Ord. 1978-13, passed 2-5-79) Penalty, see § 72.99

§ 72.05 ALLEY PARKING.

No person shall park any vehicle in any alley except for a period not exceeding 15 minutes while loading or unloading the vehicle. Parking for up to two hours shall be allowed on the south side of Eagle Alley from Meridian Street to Pine Alley and on the south side of Crane Alley from Meridian Street to Rose Alley. (Ord. 1978-13, passed 2-5-79; Am. Ord. 1980-21, passed 11-17-80; Am. Ord. 2000-10, passed 7-17-00) Penalty, see § 72.99

§ 72.06 CITY PARKING LOTS.

No person shall park any vehicle or cause to park any vehicle on any city owned off-

street parking lots without first contracting with the city for the rental of space and registering the designated vehicle for the assigned space with the Mayor's office. An assigned number designating the space that that vehicle is assigned to will be issued to the owner. No vehicle other than the assigned vehicle will be parked in the designated space. No vehicle will be parked in an assigned space that does not display on the driver's side front window the identifying permit issued to the owner by the city. Violators of the above provision shall be subject to the penalties prescribed in § 72.99. (Ord. 1985-3, passed - - ; Am. Ord. 1990-1, passed 3-5-90) Penalty, see § 72.99

§ 72.07 OVERSIZE VEHICLE PARKING.

No person shall park any vehicle or cause to park any vehicle on any city streets if such vehicle is over 19 feet in length or over six feet nine inches in width for any continuous period of time longer than two hours. (Ord. 1985-3, passed - -) Penalty, see § 72.99

§ 72.08 SNOW EMERGENCY REGULATIONS.

(A) Whenever the Mayor or his designee shall determine that the presence of snow on streets and alleys of the city shall unreasonably impede the movement of firefighting equipment, police, ambulance, or other emergency vehicles on such streets and alleys, he is hereby authorized to promulgate a snow emergency. The snow emergency shall continue until the Mayor shall determine and declare that such snow emergency has abated.

(B) Such snow emergency shall be promulgated by written order which shall be disseminated by radio broadcast, newspaper, posting of notice, or such other means as the Mayor shall deem advisable.

(C) Such order shall direct the removal of all parked vehicles from the streets and alleys described in Chapter 75, Sch. VII and such other streets as may be specifically designated by such order. For the duration of such emergency there shall be no parking of vehicles on said streets or alleys.

(D) In the event that the owner or operator of any parked vehicle in such emergency area fails to remove the same within three hours following the promulgation of such snow emergency, the Police Department shall be authorized to remove and tow away or cause to be removed and towed away such vehicle at the expense of the owner of such vehicle. Whenever a vehicle is so removed and the Police Department is able to ascertain the ownership thereof, notice of such removal and the reasons for such removal shall be furnished to the owner as

expeditiously as may be reasonable under the circumstances. (Ord. 1978-13, passed 2-5-79) Penalty, see § 72.99

§ 72.09 PARKING OR DRIVING ON PROTECTED PROPERTIES.

(A) For purposes of this section a "<u>PROTECTED PROPERTY</u>" shall be defined as any business, church, organization or property to which the public has access that has a conspicuously posted notice that said property is protected by this section reading in substantially the following form: "This property is protected by the terms of Ordinance 1989-3 of the City of Portland regarding unauthorized parking".

(B) It shall be unlawful to intentionally block entrances or exits to any parking area on a protected property in any manner unless at the direction of the owner or manager such parking is permitted. Blocking of entrances and exits shall include the parking of any vehicle in such a manner that it creates difficulty or limitations in entering or exiting the premises of the protected property, except for the purposes of repairs by municipal authorities or private contracts engaged by owners.

(C) It shall be unlawful for any person to drive a motor vehicle through any parking area or driveway of any protected property without intent to park said vehicle for purposes of conducting business at the protected property.

(D) It shall be unlawful for any person to leave an unoccupied motor vehicle upon a walkway, driveway or parking area of a protected property and leave such premises to go elsewhere without the knowledge and consent of the owner or manager of the protected property.

(E) It shall be unlawful for any person to enter upon the walkway, driveway or parking area of a protected property unless the individual entering the premises does so for the purposes of conducting business or does so with the knowledge and consent of the owner or manager of the protected property.

(F) If the owner of a public property, business, church or other organization wishes to declare and post his property as "protected property" the owner shall give notice to the city of such posting and shall cooperate in the prosecution of any car or person charged with violation of this section pursuant to said posting.

(G) The city shall furnish a form to be executed by the property owner which shall constitute notice to the city of the posting of notice of a protected property. The city shall provide for a fee determined by the Board of Public Works, a standard form notice as provided above to be posted and maintained by the owner. Such notices shall be posted in conspicuous places designating the property as a protected property, and only upon such proper posting shall compliance with this section be enforced by the city.

 (H) It shall be unlawful for anyone other than the owner or his authorized agent to remove, deface or tamper with any sign or notice posted pursuant to this section.

ENFORCEMENT

§ 72.25 AUTHORITY TO ENFORCE.

(A) Enforcement of parking provisions may be by a person designated as a special officer by the Chief of Police; such person could be other than a regular police officer.

(B) Notice of violations issued by the designated person to the owner or operator of any vehicle parked in violation are to be in duplicate, serialized, and such notice of violation should be attached to the vehicle. (Ord. 1980-21, passed 11-17-80)

§ 72.26 VEHICLE TOWING.

In addition to the penalty provided in § 72.99, any police officer, upon discovering any vehicle parked or stopped, in violation of this Traffic Code, may remove said vehicle or cause the same to be removed to any city garage or other city property or any public garage where such vehicle shall be released only upon payment for the cost of towing such vehicle away from the place where it was illegally parked or stopped, together with costs of storage. (Ord. 1978-13, passed 2-5-79) Penalty, see § 72.99

§ 72.27 WAIVING OF PARKING VIOLATIONS FOR PERSONS SERVING AS JURORS.

(A) Any individual serving on a jury in the Jay County Circuit Court or the Jay County Superior Court, shall be relieved of any parking violations issued to them while serving on a jury in the Jay Circuit Court and the Jay Superior Court. When and if the presiding Judge of said Court collects the violations issued by the city he shall certify to the Chief of Police for the city that said individuals should be relieved of the issued violation because of his or her service on the jury of the Jay Circuit or Jay Superior Court and that said violation was issued during the time said juror was in fact serving as such in the Jay County Circuit Court or the Jay County Superior Court.

(B) Upon receipt of such certification, the Chief of Police shall so note upon the records of the violation kept in the city offices that said violation was dismissed pursuant to this section.

§ 72.35 CREATION.

There shall be created an Ordinance Violations Bureau pursuant to IC 33-6-3-1 et seq., as amended, for the city. (Ord. 1989-4, passed 3-20-89)

§ 72.36 CLERK-TREASURER'S DUTIES.

(A) The City Clerk-Treasurer is appointed and shall serve as the Violations Clerk, who administers the Ordinance Violations Bureau.

(B) The Clerk-Treasurer and her staff of appointed agents shall accept written appearances, waivers of trial, admissions of violations, and payment of civil penalties in the amount and for the violation as provided in § 72.98. (Ord. 1989-4, passed 3-20-89)

§ 72.98 CIVIL PENALTY.

(A) The following schedule of ordinances (hereinafter "Ord.") and Portland Municipal Code (hereinafter "PMC") provisions shall be subject to the jurisdiction of the Ordinance Violations Bureau and any violations of said ordinances and code provisions shall be subject to the civil penalty set forth:

§ 72.99 PENALTY.

(A) Any person who shall violate any of the parking provisions of any of the sections listed in § 72.98 above may, within 24 hours of the time a notice of violation is attached to such person's motor vehicle, pay a penalty sum of \$25.00 in full satisfaction of the violation. On the lapse of such 24-hour period and within 48 hours of the time a notice of violation is attached to such person's motor vehicle, that person may pay a sum of \$35.00 in full satisfaction of the violation. If such person has not paid the sum of \$35.00 within the 48-hour period, that person shall be subject to summons to the city court for violation of such ordinance in an amount of not less than \$50.00 nor more than \$100.00, plus court costs, payable to the citv.

(1) Summons shall be served only after one written notice, by regular United States Mail, having been given notice of the failure to pay the penal sum. Such notice shall be given within 14 days of the expiration of the 48-hour period.

(2) The fact that a motor vehicle is owned by a person and the fact that the motor vehicle is in a parking place shall be prima facie evidence that the motor vehicle was parked in the parking space by the owner. (Ord. 1980-21, passed 11-17-80; Am. Ord. 2020-15, passed 11-16-20)

(B) Whenever the owner or operator of a vehicle shall willfully cause or permit such vehicle to be parked on the streets within the designated area during such prohibited times as set forth in § 72.08 and Chapter 75, Sch. VII, he shall on conviction be fined in a sum not to exceed \$50. (Ord. 1978-13, passed 2-5-79)

(C) Any person who shall violate any provision of § 72.09 shall be fined not less than \$5 nor more than \$50. (Ord. 1989-3, passed 3-20-89)

§ 73.01 STATE STATUTES APPLICABLE.

<u>§ 73.03 EXCE</u>PTIONS.

Vehicles described in § 73.02 may be operated solely for the purpose of traveling to and from the home or place of business of the operator of the vehicle to and from outside the city limits. Such travel shall be by the most direct route to the following access roads which are to be used solely for the ingress and egress described herein: East Votaw Street, West Water Street, East and West Seventh Street, Blaine Pike, and Boundary Pike. Such vehicles may be operated only on the alleys of the city until such vehicle reaches one of the above described access routes and said vehicle shall never be operated in excess of 20 miles per hour. - § 76.01 DEFINITIONS.

For the purpose of this chapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

<code>``ALCOHOLIC BEVERAGE''</code> shall have the meaning set forth in IC 7.1-1-3-5.

"CONTAINER" shall have the meaning set forth in IC $\overline{7.1\text{--}1\text{--}3\text{--}13}$.

"MOTOR VEHICLE" shall have the meaning set forth in IC 9-13-2-105, except that "MOTOR VEHICLE" as used in this chapter shall not include recreational vehicles, and which is designed to transport more than ten passengers including the operator, or any chartered passenger vehicle licensed to operate within the state. (Ord. 1992-2, passed 5-4-92)

§ 76.02 POSSESSION OR CONSUMPTION PROHIBITED.

A person who knowingly consumes an alcoholic beverage or possesses a container: that has been opened; that has a broken seal; or from which some of the contents have been removed, while in a motor vehicle that is being operated upon a public highway within the city limits, commits a violation of this chapter constituting an ordinance violation. (Ord. 1992-2, passed 5-4-92) Penalty, see § 76.99

$\$ 76.03 OPERATOR OR OWNER OF MOTOR VEHICLE IN VIOLATION.

(A) The operator or owner of a motor vehicle who, while in the motor vehicle is in operation knowingly keeps or allows to be kept in an area of the motor vehicle that is accessible to the operator or a passenger a container that has been opened; that has a broken seal; or from which some of the contents have been removed commits a violation of this chapter constituting an ordinance violation.

(B) Notwithstanding § 76.01, the operator of a recreational vehicle or chartered passenger vehicle licensed to operate within the state who, while the motor vehicle is in operation, knowingly keeps or allows to be kept in an area of the recreational vehicle or chartered passenger vehicle that is accessible to the

§ 76.04 CITATIONS.

An officer of the Portland Police Department may issue a City Ordinance Violation Citation to a person who violates this chapter. (Ord. 1992-2, passed 5-4-92)

§ 76.05 SIGNS.

Signs giving notice of this prohibition of open alcoholic beverage containers shall be posted giving notice of such regulation at all locations deemed appropriate by the city. (Ord. 1992-2, passed 5-4-92)

§ 76.99 PENALTY.

An individual shall, upon first conviction for a violation of this chapter, be subject to a fine of not less than \$50 and not more than \$2,500. An individual shall, upon each subsequent conviction for a violation of this chapter, be subject to a fine of not less than \$100 and not more than \$2,500. § 77.01 DEFINITIONS.

For the purpose of this chapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

"GOLF CART." A vehicle with four wheels originally designed for operation on a golf course and powered by a battery or internal combustion motor.

"DRIVER'S LICENSE." A valid license to operate a motor vehicle issued by Indiana or any other state.

"FINANCIAL RESPONSIBILITY." Liability insurance coverage on a golf cart in an amount not less than required by Indiana law for motor vehicles operated on public highways in the State of Indiana. (Ord. 2006-28, passed 12-4-06)

§ 77.02 OPERATION OF GOLF CART.

The operation of a golf cart within the City of Portland is strictly prohibited unless the golf cart is operated and equipped in full compliance with this chapter. (Ord. 2006-28, passed 12-4-06) Penalty, see § 77.99

§ 77.03 OPERATOR.

Only persons over 16 years of age and holding a driver's license may operate a golf cart. (Ord. 2006-28, passed 12-4-06) Penalty, see § 77.99

§ 77.04 FINANCIAL RESPONSIBILITY.

The financial ability of the operator or owner notwithstanding, the operator of a golf cart must show financial responsibility when operating a golf cart. Written proof of financial responsibility must be available either on the golf cart or carried by the operator at all times. (Ord. 2006-28, passed 12-4-06) Penalty, see § 77.99

§ 77.05 TIME OF OPERATION.

Golf carts shall not be operated on city street during one-half hour after sunset to onehalf hour before sunrise unless the golf cart is equipped with two operating headlights (one on each side of the front of the golf cart) and two operating tail lights with brake lights (one on each side of the rear of the golf cart) which are visible from a distance of 500 feet. (Ord. 2006-28, passed 12-4-06) Penalty, see § 77.99

§ 77.06 PLACE OF OPERATION.

Golf carts may be operated on city street which have a posted speed limit of 30 miles per hour or less. Golf carts may not be operated on sidewalks or on the following national or state highways except to cross these highways at intersections in a path 90 degrees to the highways: SR 67 (Votaw Street), US 27 (Meridian Street) or SR 26 (Water Street). (Ord. 2006-28, passed 12-4-06) Penalty, see § 77.99

§ 77.07 OCCUPANTS.

The number of occupants in a golf cart shall be limited to the number of persons for whom factory seating is installed and provided on the golf cart. The operator and all occupants shall be seated in the golf cart and no part of the body of the operator or occupant shall extend outside the perimeter of the golf cart while the golf cart is being operated. (Ord. 2006-28, passed 12-4-06) Penalty, see § 77.99

§ 77.08 TRAFFIC RULES.

The operator of the golf cart shall comply with all traffic rules and regulations adopted by the State of Indiana and the City of Portland which govern the operation of motor vehicles. (Ord. 2006-28, passed 12-4-06) Penalty, see § 77.99

§ 77.09 SLOW MOVING VEHICLE SIGN.

All golf carts must display on the back of the golf cart a "slow moving vehicle" sign of the same type required under Indiana law. (Ord. 2006-28, passed 12-4-06)

§ 77.10 REGISTRATION AND FEE.

(A) All golf carts which are operated on a city street shall be registered with the city annually, except as herein provided, with the Portland Police Department. The Police Department shall inspect and register each golf cart to confirm that it complies with all requirements of this section and educate the owner regarding applicable traffic rules. Upon being registered, a registration sticker shall be issued by the (B) A registration fee of \$10 shall be charged annually for all privately owned golf carts operated on a city street of Portland. All registrations shall be renewed annually January 1st and shall expire on December 31st of the following year. Privately owned golf carts that were registered in 2022 remain valid until April 30, 2023. Fees collected shall be deposited into the Police Continuing Education Fund. (Ord. 2022-17, passed 12-19-22)

§ 77.11 RECIPROCITY.

This section shall apply to anyone who has received a permit to operate a golf cart in conjunction with a recognized special event or festival. A person who operates a golf cart within the city limits of Portland that displays a valid registration issued by the organizer of a recognized special event or festival shall not be required to pay a registration fee to the City of Portland on the following conditions:

 (A) The organizer of the special event or festival seeks the prior approval of the City Council for reciprocity for their event or festival, annually;

(B) The registration requirements for the issuance of a registration or permit of the special event or festival contain, at a minimum, the requirements set out in Sections 77.03 through 77.09 of this chapter;

(C) The organizer of the special event or festival shall educate owners prior to the issuance of any registration or permit on the traffic rules regarding golf cart operation within the City of Portland;

(D) The special event or festival registration or permit shall be affixed to the golf cart in a location that is clearly visible at all times;

(E) The organizer of the special event shall provide a copy of the required registration information for all of the permits that it issues to the Chief of Police or his designee; and,

(F) The reciprocity shall not exceed the duration of the registration or permit of the special event or festival.(Ord. 2022-17, passed 12-19-22)

§ 77.12 PENALTY FOR NON-REGISTRATION.

Any person found to be operating a privately owned golf cart on a city street that is not registered pursuant to § 77.10, above, shall be subject to a fine of \$50 for the first violation and an additional \$25 for each subsequent violation over the next 12 months. (Ord. 2022-17, passed 12-19-22) 2023 s-35

GOLF CARTS

A violation of any provision of this chapter, except a violation of § 77.10, shall constitute a violation of the Portland City Code. An owner, lessee or operator may be cited to appear in a court of competent jurisdiction by issuance of an Indian uniform traffic ticket. Upon a finding by such court that an owner, lessee or operator has violated any provision of this chapter, except a violation of § 77.10, such person shall be subject to a fine not to exceed \$200 for each offense along with court costs in the amount the same now exists or may hereafter be determined by ordinance or statute.
